Introduction

Project Description

NeON Arts is a new initiative that builds on the NYC Department of Probation's successful efforts to advance public safety by engaging probation clients in the arts. Made possible through a collaboration between the private and public sectors, NeON Arts funds local arts projects in seven communities that are home to large numbers of people on probation. NeON Arts connects community-based artists and local arts organizations to probation clients who report to a Neighborhood Opportunity Network (NeON) location. Artists and clients collaborate on projects in a variety of disciplines, including dance, music, theater, visual arts, poetry, and digital media. In addition to creating meaningful arts projects that benefit their local community, participants learn important skills and develop positive peer relationships. The partnering arts organizations are selected by the local NeON stakeholder groups, which comprise DOP clients, DOP staff, key members of the community, and local business and cultural leaders.

The seven NeON communities are Brownsville (Brooklyn), East New York (Brooklyn), Bedford-Stuyvesant (Brooklyn—opening soon), Harlem (Manhattan), South Jamaica (Queens), the South Bronx, and Northern Staten Island. Carnegie Hall's Weill Music Institute, an ongoing arts partner of the NYC Department of Probation, serves as the intermediary organization to provide support and facilitation for NeON Arts.

Timeline and Deadlines

There will be four funding award periods beginning March 2014 through June 2015. Applications must be submitted to **NeONArts@carnegiehall.org** no later than 11:59 PM on the due dates listed below. Prior to the deadline, there will be an opportunity for a presentation to the NeON stakeholder groups. Notifications of awards for Project Period #1 will be made in early February 2014. Notification dates for Project Periods thereafter will be determined at a later date.

Proposals can be submitted for different project periods, each with a corresponding application deadline, as outlined below. Applications received after the given due date may be considered for the next grant cycle.

Project Period #1 (March 1-June 30, 2014) application due: January 15, 2014

Project Period #2 (July 1-October 31, 2014) application due: April 15, 2014

Project Period #3 (November 1, 2014-February 28, 2015) application due: August 15, 2014

Project Period #4 (March 1-June 30, 2015) application due: December 15, 2014

Project Criteria

In order for an application to be considered for funding, an arts organization should be sure to follow the criteria outlined below:

- 1. Applications should reflect the mission of the NYC Department of Probation and the NeON Arts Initiative. To learn more, please refer to the NYC Department of Probation's <u>website</u>.
- 2. Applications should support the goals of the local NeON. Learn as much as you can about the particular NeON, its community, and its clients that you are proposing to serve. For more information about how to contact your local NeON stakeholder group and to find out about attending an upcoming meeting, please e-mail NeONArts@carnegiehall.org.
- 3. Make sure to include the following points in your project summary:
 - a. A clear description of the central art-making activities of your project
 - b. The anticipated project period, frequency, and proposed schedule of visits/workshops
 - c. Why you believe the project will engage the clients or community members (or both) it will serve, along with the approximate number of DOP clients and community members you propose to serve
 - d. How your project would include or culminate in public performances or exhibitions; sharing with the community is a priority of this initiative
 - e. Any employment opportunities or connections to career development for participants
 - f. How your project would enhance the connection between the NeON and the community in which it is located
 - g. How the project would help the NeON develop and sustain capacity for doing work in the arts in the future
